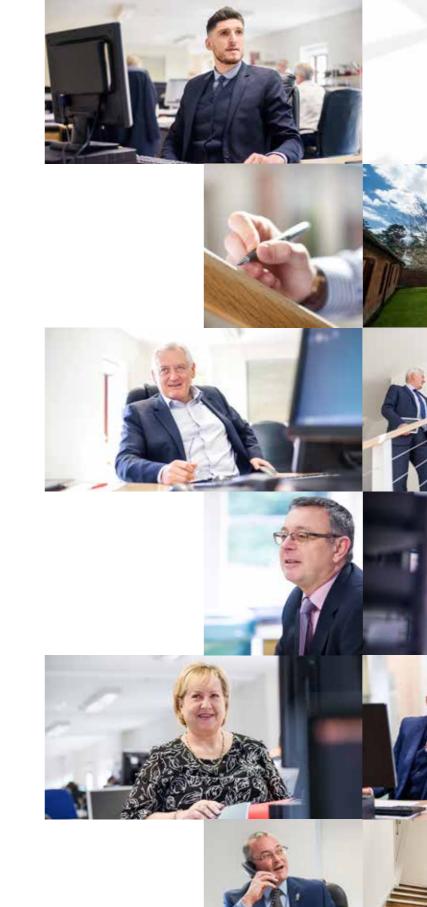

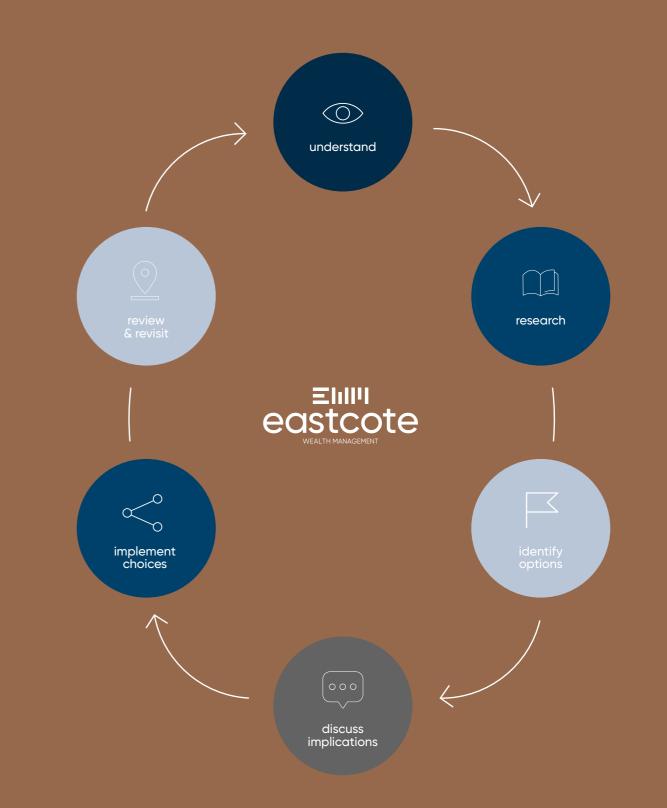

KEY-PERSON INSURANCE

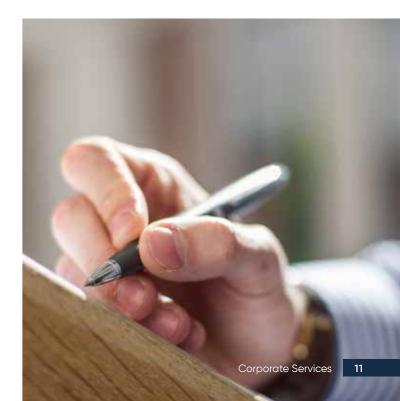
